Part A: Pupil premium strategy plan

Statement of intent

Our current priorities are:

- To accelerate rates of progress, where necessary, to ensure that pupils in receipt of pupil premium funding, including those with additional barriers to learning, achieve outcomes in line with the school's expectations.
- To provide additional adult support, where necessary, to facilitate emotional development, counselling sessions and small group work and to provide associated staff training to deliver these sessions effectively.
- To ensure equality of access to experiences in order to broaden horizons for eligible pupils.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Some children eligible for PP have a range of social, emotional and mental health difficulties which are affecting their readiness to learn
2	Some children eligible for PP have gaps in prior learning or have struggled to aquire early skills in reading, writing and maths.
3	Some children eligible for PP lack the skills of confidence, independence and resilience in their approach to learning.
4	Attendance rates for some children eligible for certain PP children are low which has an impact on progress and achievement.
5	Complex family circumstances in the home have an impact on the children's emotional wellbeing in school. This is a barrier to progress.

Intended outcomes

The social and emotional well-being of vulnerable children is protected and enhanced, children are able to learn and make progress. Outcome

- Good progress has been made since entry in Sept, with 50% PP children making accelerated progress in reading, 58% in maths, 38% in writing.
- Attainment of Pupil Premium children without additional need remains an area for school development. (Raise as a focus area)
- Attainment for Pupil Premium children with additional SEND is comparable with non PP children with SEND

Lessons learned

- Further analysis of data around key areas of non-SEND PP concern, identify specific areas for focus.
- Continue to raise priority and awareness for non-SEND PP children.
- Raise awareness of PP children with SEND
- Ensure focus on PP, QFT with the continuation of marking first and prioritizing during lesson time.
- Continue with provision of individualised targets for all PP children.
- Outline of provision to be included within targets, individual provision mapping.

To build relationships with children/families. To provide/locate support. To liaise with relevant services.

The outcomes of Play Therapy may be general e.g. a reduction in anxiety and raised self-esteem, or more specific such as a change in behaviour and improved relations with family and friends. (British assoc. of Play Therapists)

Outcome

- ELSA sessions very successful, provision of TA with timetabled sessions supporting up to 20 children. Room and resource base established.
- Worry postbox very well used and supportive for children.
- From entry and exit data, 100 % children felt better after counselling following. Parental feedback very positive.
- SDQ scores (emotional screening questionnaire) for children receiving play therapy showed significant improvement for all children. (until April 2023)

Lessons Learned

- Ensure all staff aware of pastoral offer
- Continue to disseminate all new behaviour management strategy around school to all staff body, including induction for new members.
- Ensure all team around a child are aware of strategies and whole staff have general awareness.
- Continue to develop Trauma informed practice – Recovery through relationships training.

To support children identified through Progress Meetings who are at risk of slow progress and run appropriate interventions. Part fund TAs to deliver 1:1/small group interventions (according to need) to be provided before and during school.

e.g.

 Little Wandle catch up materials Ensure that our children have opportunities for small group/1:1 intervention with trained Teaching Assistants.

EEF report that research which focuses on TAs who provide 1:1 or small group support shows a positive benefit. EEF also report that where the tuition is delivered by TAs there is evidence that training and the use of a structured programme is beneficial.

Through pre and post baseline assessments we have gathered evidence which shows

Outcome

- 82% Pupil Premium children without SEND achieved ARE in reading following Little Wandle interventions in KS1.
- 50% of children in Maths seeds group demonstrated accelerated levels of progress, 50% expected. 47% of Nessy group demonstrated accelerated progress, 41% in writing. All further Nessy children made expected progress.
- 100% of children in KS2 SATs booster reading achieved standard or above from a start of below standard. 83% of children in maths booster attained working at a higher standard in KS2 SATs from at expected standard.

Lessons learned

- Continue to raise priority and awareness for non-SEND PP children.
- Ensure focus on PP, QFT with the continuation of marking first and prioritizing during lesson time.
- Continue with provision of individualised targets for all PP children.
- Outline of provision to be included within targets.
- Further consideration of maths boosters and focus in KS2, further input around moving to expected.
